

**CalStateTEACH****Application for the Early Completion Option**

Deadline 5:00 p.m. Friday of the 10th Week of Term One

Application Instructions:

The CalStateTEACH Early Completion Option permits qualified applicants to complete the CalStateTEACH program on an accelerated schedule. To qualify for the Early Completion Option, candidates must:

1. Verify BA from a regionally accredited institution
2. Verify Subject Matter Competence <http://www.cset.nesinc.com/>
3. Verify Basic Skills Competence

4. Pass the National Evaluation Series (NES) Assessment of Professional Knowledge (APK): Elementary (Test code 051) for Multiple Subjects candidates

5. Pass the Preliminary Education Technology Test

6. Be accepted into the CalStateTEACH Intern Program (Term Two)
7. Be eligible for Term Two enrollment
8. Submit an Early Completion Application no later than the 10th week of Term One
9. Earn a grade of "A" for Term One
10. Apply for a Multiple Subject Intern Credential through CalStateTEACH
11. Receive a written recommendation for the Early Completion Option from Term One Faculty
12. Meet Professional Fitness Requirements: TB test and Certificate of Clearance

Early Completion Option Process:

1. Once admitted to the Early Completion Option, continuance in the Early Completion option depends upon passing the 4 tasks of the edTPA Teaching Performance Assessment* (Summer 2018) or the two Cycles of the CalTPA 2.0. Candidates who do not successfully pass the TPA on the first try may not continue in the Early Completion Option.
2. Candidates admitted to the Early Completion Option, enroll in CST 432 and CST 432S (Term 2), during which they will be supervised in their classrooms, complete selected CalStateTEACH activities from Term Two, take the TPA and pass the Reading Instruction Competence Assessment (RICA) <http://www.rica.nesinc.com/> ,
3. Upon successful completion of CST 432 and CST 432S, achieving a passing score on the Preliminary Education Technology Test, the Teaching Performance Assessment (TPA) and the Reading Instruction Competence Assessment (RICA) <http://www.rica.nesinc.com/> , candidates will be recommended for a Preliminary Multiple Subject Credential.
